
Oklahoma Natural filed the Application herein on June 26, 2009, seeking a review and change in its rates, charges, tariffs, and terms and conditions of service. In connection with such review, the Staff of the Commission's Public Utility Division ("Staff") will require access to and/or copies of information that Oklahoma Natural deems confidential and/or proprietary. Oklahoma Natural anticipates that the Attorney General and intervening parties will also request access to such information.

To facilitate Staff's review, Oklahoma Natural requests that the Commission issue a protective order, to cover the following the materials and information:

Critical infrastructure (Homeland Security) information, specific employee payroll and records, employment tax returns, executive compensation studies, ONEOK corporate tax returns, ONEOK Board minutes, internal management memoranda, non-public Sarbanes-Oxley compliance information, confidential contracts and agreements, commercially sensitive customer information, and underlying supportive documentation for these items.

Oklahoma Natural reserves the right to seek an amendment to the protective order to cover additional information and materials should such be necessary.

WHEREFORE, Oklahoma Natural respectfully requests that the Commission issue a protective order covering the materials described above.


