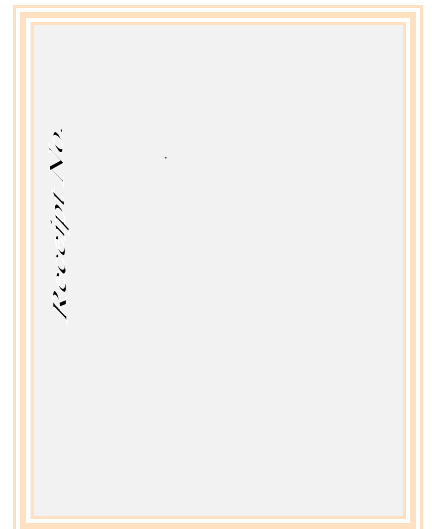

3. List Applicant's contact person information for the OCC office staff to contact if they have any questions about your application.
4. Show the total number of vehicles reflected on Part 1 **OR** check the box for **ALL** vehicles listed under the initial permit to be operated under the extended permit.
5. Show the total cost of the harvest permit as reflected on Part 1 or calculate the cost at \$8.75 per axle for all vehicles (power units only - a trailer is not a vehicle).
