UNIFIED CARRIER REGISTRATION PROGRAM - Year **2016**

IMPORTANT NOTICE FOR ALL INTERSTATE MOTOR CARRIERS, MOTOR PRIVATE CARRIERS, FREIGHT FORWARDERS, BROKERS & LEASING COMPANIES

If you operate as a motor or private carrier in interstate or international commerce, or if you make the arrangements for the transportation of cargo and goods, the Unified Carrier Registration Agreement (UCR) applies to your business. The UCR requires individuals and companies, based in Oklahoma, that operate commercial motor vehicles in interstate or international commerce to register their business with Oklahoma and pay an annual fee based on the size of their fleet. Companies operating solely as brokers, freight forwarders or leasing companies are required to register their business and pay a fee of \$76. Companies providing both motor carrier services as well as broker, freight forwarder or leasing services are required to pay the fee level set at the motor carrier level. *Private motor carriers of passengers are not subject to the UCR program.*

A commercial motor vehicle@ is defined as a self-propelled vehicle used on the highways in commerce principally to transport passengers or cargo, if the vehicle: (a) has a gross vehicle weight rating or gross vehicle weight of 10,001 pounds or more; (b) is designed to transport 11 or more passengers (including the driver); or (c) is used in transporting hazardous materials in a quantity requiring placarding.

THE FEE BRACKETS FOR MOTOR CARRIERS ARE AS FOLLOWS:

Example: A motor carrier operating four tractors and nine straight trucks has a fleet size of thirteen commercial motor vehicles and pays \$452.00. TRAILERS ARE NO LONGER INCLUDED IN THE FLEET SIZE NUMBER.

IMPORTANT: You must register for the calendar year 2016 by December 31, 2015, in order to operate in interstate commerce. To avoid delays, it is highly recommended that you register on-line at www.ucr.in.gov and follow the step-by-step instructions. Payments may be made on-line using MasterCard, Visa or your checking account. If you operated in 2014 and/or 2015 but did not register in the UCR, you must pay 2014 and/or 2015 in addition to 2016 UCR fees to avoid possible enforcement action.
