THE OFFICE OF ADMINISTRATIVE PROCEEDINGS, COURT CLERK'S OFFICE IS REQUESTING THE DISMISSAL OF THE FOLLOWING CAUSES FOR FAILURE TO COMPLY WITH COMMISSION RULE:

- (1) 165:5-9-2(e)(4)(A) **Dismissal** Failure to Submit a proposed Order to the Administrative Law Judge or the Commission within thirty(30) days after the recommendation date or as directed by the Administrative Law Judge or the Commission.
- (2) 165:5-9-2(e)(4)(B) **Dismissal** Failure to set a cause on a day certain.
- (3) 165:5-15-1(d) **Order titles and numbers:** An order of the Commission, descriptively titled, shall be issued for all motions and other matters set for hearing, except for continuances, and all such orders shall be given an order number.
- (4) 165:5-1-19 **Withdrawal of application:** If the applicant fails to provide the Division requested supplemental information within six(6) months of the request, the application shall be considered withdrawn unless the time is extended by written request for good cause shown.

THE CAUSE MAY BE BROUGHT IN COMPLIANCE PRIOR TO 4:00 PM ON **January 13, 2014** BY EITHER:

- (1) OAC-ROP 165: 5-1-19, OAC-ROP 165: 5-15-1(d) and OAC-ROP 165-9-2(e)(4)(A): AN ORDER MUST BE SIGNED PRIOR TO **4:00 PM**.
- (2) OAC-ROP 165: 5-9-2(e)(4)(B): THE CAUSE MUST BE SET BY A PREHEARING CONFERENCE AGREEMENT, SCHEDULING FORM OR AMENDED NOTICE OF HEARING.

THOSE CAUSES STILL IN NON-COMPLIANCE WITH RULE OAC-ROP 165:5-1-19, OAC-ROP 165: 5-9-2(e)(4)(A) or 165: 5-9-2(e)(4)(B) or OAC-ROP 165:5-15-1(d) AT **4:00 PM ON January 13, 2014** WILL BE PRESENTED BEFORE AN ADMINISTRATIVE LAW JUDGE ON THE DISPOSITION DOCKET ON **January 14, 2014 at 10:00 AM, IN COURT ROOM C.** THE PARTIES OF RECORD OBJECTING TO THE DISMISSAL OF THE CAUSE MAY APPEAR AT DOCKET CALL AND SHOW CAUSE WHY THE CAUSE SHOULD NOT BE DISMISSED. OTHERWISE, THE OFFICE OF ADMINISTRATIVE PROCEEDINGS, COURT CLERK'S OFFICE WILL PRESENT AN ORDER DISMISSING CAUSE ON EACH CAUSE TO THE ADMINISTRATIVE LAW JUDGE FOR A RECOMMENDATION TO THE COMMISSION.
