MINIMUM QUALIFICATIONS:

Mandated by statute 47 O.S. §172-1., 1999 Supp: Applicants "shall be high school graduates and shall have had at least three (3) years practical experience in the transportation industry or in the field of law enforcement." And one (1) year of experience as a CLEET-certified peace officer.

SPECIAL REQUIREMENTS: Applicants must be willing and able to be on call twenty-four (24) hours per day; be willing to travel frequently and be away from home for extended periods of time; be willing to temporarily relocate to the place of assignment; and be willing to accept the physical discomforts and/or dangers inherent in the work.

NOTE: THIS POSITION REQUIRES SELECTED CANDIDATE TO LIVE WITHIN 50 MILES OF ASSIGNED FACILITY

OCC NOTE: Applicant must be willing to work shifts that will routinely include weekends and also include early days or evenings/nights. This position is located at a facility that operates up to 24 hours a day, 7 days a week and all employees are subject to assignment of all shifts.

TYPICAL FUNCTIONS:

- Patrols roads and highways or operates a weigh station to identify motor carriers operating in violation of state regulatory laws, stops apparent violators, inspects vehicles and documents to determine compliance with applicable laws, rules and regulations.
- Enforce state size and weight laws and overweight and oversize permits.
- Impounds improperly registered vehicles until vehicle is properly registered and applicable fees are paid.
- Issues citations or warnings, determining applicable fees and penalties in accordance with state law, serves warrants, writs and notices issued by the Corporation Commission; may detain violators; accept bonds guaranteeing court appearance; testifies at trials and hearings.
- Provides assistance and information to law enforcement entities and motor vehicle licenses agents with regard to state motor vehicle and motor fuel laws.
- Investigates complaints regarding service, damage settlements, illegal dumping and storage or transportation of deleterious substances.
- Provides initial response to accident scenes involving deleterious and hazardous materials, notifies appropriate agencies and local authorities; provides technical guidance or supervision to others at the scene.
