the Commission permission to enter my (our) property located as described above in order to investigate and/or abate the existence of seeping natural gas on the property, to attempt to locate a well drilled for the exploration or production of oil or gas, including an injection or disposal well, to plug any such well if the well is the source of seeping natural gas on the property, and to otherwise attempt to locate the source of seeping natural gas that may exist on the property. I (we) agree that this work is necessary to attempt to locate and abate the source of the seeping natural gas.

I (we) understand that excavations on the property may be necessary. All trash and debris associated with work on the property will be removed and excavated areas will be filled with soil when work at the site is completed.

I (we) understand and agree that the Commission shall not be responsible for damages to the property or improvements resulting from the investigation and/or abatement of seeping natural gas occurrences at the property, and that any person entering upon the property pursuant to the authority of the Commission shall not be liable or held responsible for any damages resulting from operations reasonably necessary or proper for the investigation of the seeping natural gas occurrence or the abatement of associated hazards.

I (we) also understand and agree that any person entering upon the property to investigate and/or abate the associated hazards of a seeping natural gas occurrence, pursuant to the authority of the Commission, shall not be held to have assumed responsibility for future abatement work on the property or be liable for damages or otherwise for conditions subsequently arising from or in connection with the property.

If it is determined that the installation of a vapor extraction system or other system is necessary to divert seeping natural gas away from the structure on the property, or if other means or devices are necessary to otherwise abate the hazards, I (we) understand and agree that when installation is complete, I (we) will be responsible for the use, maintenance, operation, and any closure or removal of such system, means, or devices.

I (we) further agree that I (we) am/are the legal owner(s) of the property described above and have the legal authority to enter into this agreement. This agreement is binding upon the property owner(s), and owner(s) heirs, successors in interest, assigns and transferees.
